Rheological Testing of Coatings

Greg Kamykowski - *TA Instruments*

The rheological properties of coatings are critically important to their application and performance properties. The coatings formulator must consider issues like ease of application, spatter resistance, leveling properties, and sagging resistance when making a coating, as well as the ultimate properties of the coating after it has been applied to a substrate.

Rheological testing is a reliable and convenient way of characterizing coatings to gain insight into these issues. The different kinds of rheological testing, a description of the experimental parameters in rheology, and how rheological properties correlate with product performance will be discussed in this presentation.

Greg Kamykowski is a Senior Applications Scientist in Rheology for TA Instruments in Schaumburg Illinois. He obtained his BS in Chemistry from Loyola University of Chicago and his PhD in Physical Chemistry from the University of Wisconsin – Madison. He has been involved with rheology and rheological testing in various degrees throughout his industrial career and is a member of the Society of Plastics Engineers and the Society of Rheology.

Rheology Modifiers for Waterborne Coatings

Waterborne coatings provide their own unique challenges, when the chemist is formulating a product. Selection of the proper Rheology modifier also has a significant impact on many coating performance properties. Such as, gloss, sheen, scrub resistance, blocking, and package stability.

The various types of Rheology modifiers, formulation guidelines, and the role of these additives on overall coating performance will be discussed in this presentation.

Joe Mc Junkins is a Senior Technical Service Chemist with CoAtex, Inc. based in Chester, SC. He has over twenty years of formulation and product development experience in solvent and waterborne coatings. He is a patent owner for various polymer dispersions, and printing ink applications.

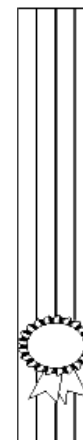

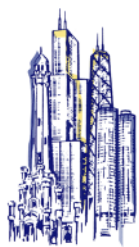
